PENNSYLVANIA, ADOPTING THE BRIAR CREEK TOWNSHIP AND NORTH CENTRE TOWNSHIP
MULTIMUNICIPAL COMPREHENSIVE PLAN.**

WHEREAS, the Pennsylvania Municipalities Planning Code, hereafter referred MPC (act of 1968, P.L. 805, No. 247, as amended), empowers municipalities, individually or jointly, to plan for their development and govern the same by zoning and subdivision and land development ordinances; and

WHEREAS, the municipalities of Briar Creek Township and North Center Township, Columbia County, each being characterized by similar demographics, identities, common issues, and sharing common boundaries; and

WHEREAS, the two municipalities have joined together for the purpose of mutual cooperation through multimunicipal planning; and

WHEREAS, a joint steering committee comprised of representatives of each of the two municipalities was formed to oversee the development of a multimunicipal comprehensive plan; and

WHEREAS, a public involvement process that included public meetings, interviews, and an on-line survey provided opportunities for public input; and

WHEREAS, a public meeting was held on November 8, 2021 to accept public comments on the draft Multimunicipal Comprehensive Plan (the "Plan"); and

WHEREAS, the Plan was reviewed and recommended by the Briar Creek Township Planning Commission; and

WHEREAS, Columbia County, contiguous municipalities, the Berwick Area School District, and the Central Columbia School District have reviewed or been given the opportunity to review the Plan per the MPC; and

WHEREAS, the Plan was made available for public review via the Township's website; and

WHEREAS, Briar Creek Township held a public hearing on January 10, 2022 to hear and consider public comments; and,

WHEREAS, the Briar Creek Township Board of Supervisors has found that the Plan is beneficial to the health, safety, and welfare of its citizens.

NOW THEREFORE BE IT RESOLVED AND ENACTED BY THE BRIAR CREEK TOWNSHIP BOARD OF SUPERVISORS THAT:

SECTION 1:




